- Community Outreach - We have 235 email and 250 text message subscribers. Followers include 335 on Facebook, 259 on BlueSky, and 74 on Instagram.
- T-shirt sales - Forms to order were on the table in the meeting room or contact Heidi.
- Texting Platform - Heidi was able to send a bulk email out to all the phone numbers of local Democrats that she had. A few folks have been unsubscribed, but Heidi plans to grow the list.

Old Business:

- Adopt-a-Highway sign - It has been ordered, but we're not sure when it will be installed.
- Midterm Elections discussion - Many thanks to Brenda K. who shared a document last month showing which local and state seats were open in the 2026 elections, and links to local, non-elected boards. Natrona County has a guide that could serve as a template for us. It was passed around.
- Electronic Billboards - We will discuss this at a future meeting.

New Business:

Updates from Wyoming Democratic Party State Committee Meeting

- The state voted on using Mobilize to list our local events. The state party would like every county party to contribute \$50/month towards the cost. Since we are a new party and have a small amount in our account, the cost would be too much for us at this time. Heidi suggested that we might be able to afford \$20/month. We will discuss this again if asked by the WDP.
- The state party would also like one person from each county to be represented on the following caucuses: Labor; Women; and Minorities. Each caucus meets once a month on Zoom and has a vote at state party meetings. It's a great way to discuss issues prior to the legislative session.
- In 2026, there will be discussion of party platform bylaws. More information to come.
- Billy M. said there was a good turnout at the meeting, and it was a good way to become re-energized.

- December's pizza night will be on Wed., Dec. 3rd, at 5:15 pm at Pizza Carrello.
- There will not be a coffee date or monthly meeting in December.
- Tuesday, Dec. 2nd will be the third and final reading of the repeal of the Malicious Harms ordinance at 6 pm in the Gillette City Council Chambers, 201 E. 5th Street. People are encouraged to attend. Heidi will be meeting with Mayor Lundvall soon.
